**Pre-Filing Supplemental Information – Response to Seminole Tribe of Florida Comments**

Dear Ms. Bose:

On May 14, 2018, Florida Gas Transmission Company, LLC (“FGT”) received authorization from the Federal Energy Regulatory Commission (“Commission”) for use of the Pre-Filing Process for the Turnpike-Palmetto Road Relocation Project. On July 17, 2018, the Commission issued its Notice Of Intent (“NOI”) to Prepare an Environmental Assessment for the planned Turnpike-Palmetto Road Relocation Project, with Comments (“Scoping Comments”) due at the Commission on or before 5:00 pm Eastern Time on August 16, 2018.

In response to the Seminole Tribe of Florida (“STOF”) comments submitted to Mr. Paul Friedman at the Commission on September 10, 2018, and filed at Commission in Docket No. PF18-5-000 on September 25, 2018, FGT has enclosed herewith a copy of its Response to the STOF Comments for filing with the Commission in the above referenced proceeding. FGT respectfully requests that the information designated as “**PUBLIC**” be placed on the FERC eLibrary website as “Public Information”. In addition, FGT respectfully requests that the information identified as containing “**CU/PRIVILEGED INFORMATION - DO NOT RELEASE**” be afforded privileged treatment pursuant to Section 388.112 of the Commission’s Rules of Practice and Procedure. A grant of this request for privileged treatment would be consistent with the Commission’s treatment of such information in previous proceedings.

In response to your comment submitted to Mr. Paul Friedman at the Federal Energy Regulatory Commission (FERC) on September 10, 2018, and filed at FERC in Docket No. PF18-5-000 on September 25, 2018, Florida Gas Transmission Company (FGT) respectfully submits the following information.


FGT's work within the project area labeled AB MP 884.9 will consist of the following activities:

- Cut and isolate the existing 18-inch mainline pipeline,
- Install plate, install two small diameter taps and two small diameter valves for grouting, and
- Fill the existing 18-inch mainline pipeline being abandoned at this location with grout.

All work proposed at AB MP 884.9 will occur within the proposed access easement and temporary workspace as depicted on the enclosed alignment sheet. Prior to the commencement of any work at AB MP 884.9, FGT's archeological consultant will excavate a minimum of 23 shovel tests at 25 and 50-meter intervals throughout the project area to determine the presence or absence of cultural deposits. The locations of proposed shovel tests are shown on the enclosed figure. If cultural deposits are identified, they will be delineated with two consecutive negative shovel tests at 12.5 and 25-meter intervals in each of the cardinal directions from the site boundary. Shovel test results will be documented in the Cultural Resource Assessment Survey (CRAS) and shared with the Seminole Tribe of Florida.

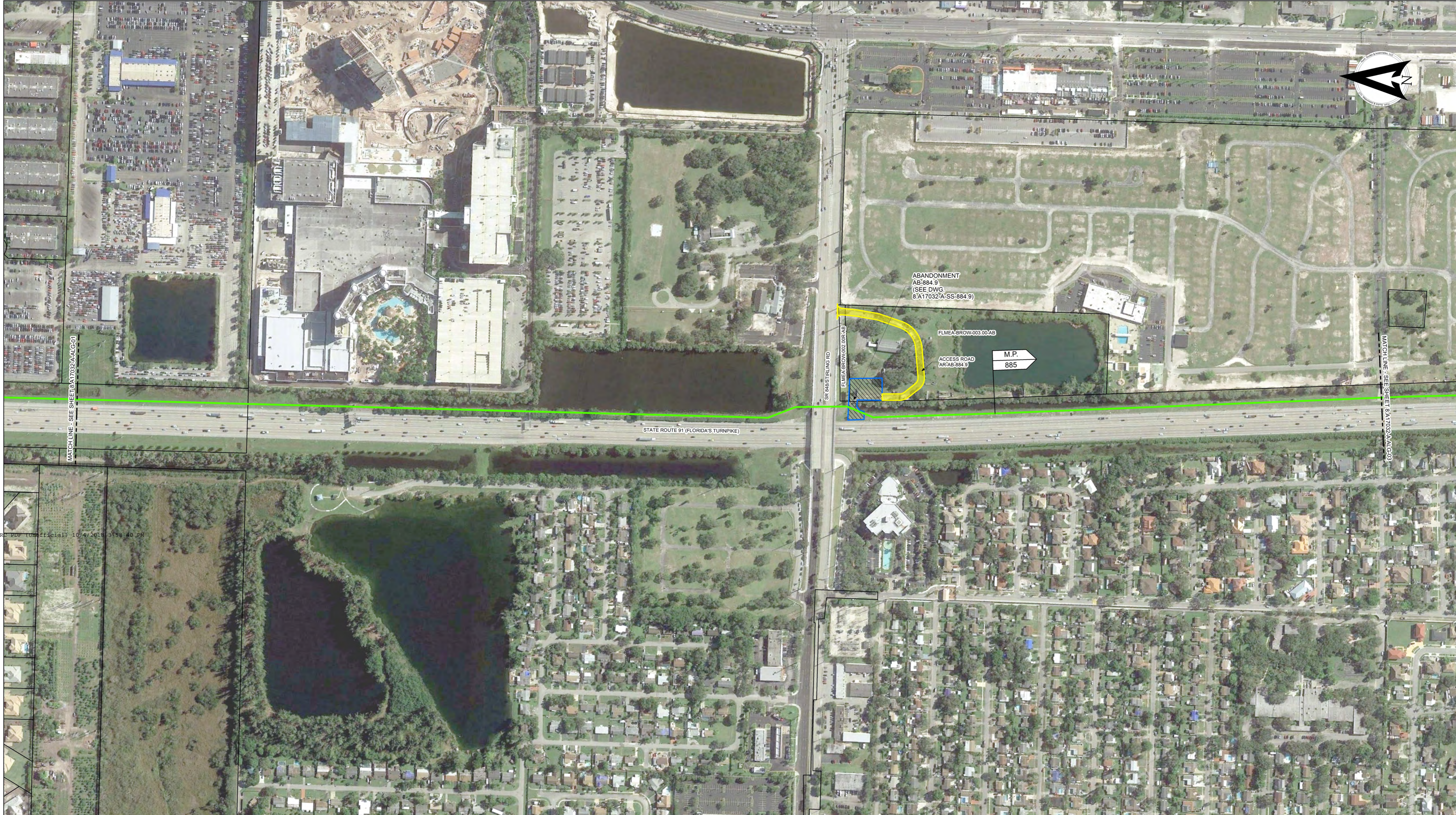

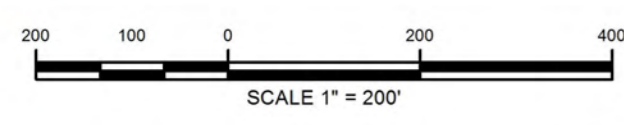
